2 Declaration of Interests.

- 3 **Minutes**. It was agreed that the minutes of the Maisemore Parish Council meeting held on 13 November 2023 formed a true record – however the official copy was not present at the meeting and hence will be signed at the next meeting

4 Reports.

a. Clerk – the Clerk's report had been received by email and was read out:

- 3. Tax Base: When I notified TBC of our unchanged precept their software indicated an unchanged tax base of £31.97.

d. Speed Reduction Initiatives – The weather has been problematic and new volunteers are being sought. A survey of volunteers has been done to determine the best times for availability

f. Maisemore PC Website – The Clerk had emailed: "*Website etc is ready to start using. As soon as I'm able I'll push on with that.*" Councillor Jones requested that we see it in draft prior to it going live.

g. Environmental Group – No report. Councillor Scott to liaise with Andrew Cooley re the possibility of planting free trees.

h. Churchyard Maintenance – No further information. Cllr. Jones still to request costs from PCC.

i. The Grapevine – January edition is being prepared. Things to include – "Four Parishes" magazine subscriptions, people walking around village at night not very visible, cars going around the village at night too fast, MADS next production.

j. The Bridge Cross – Awaiting feedback from Clerk re negotiations with insurers.

k. School Provision Places – Nothing to report

I. Noise & Related Issues – The Clerk had emailed: "".... not more than 28 days in total in any calendar year..." They need planning permission!!!"

- 5 Hedgerows. The Clerk had emailed: "Church Rise plans. It looks as if the hedges belong to the householders. Nobody from Church Rise ever forwarded any emails from GCC or TBC so there was nowhere to go with that line of enquiry." The plans received from Land Registry were tabled and certainly appeared to agree with those looked at at the November meeting. There is no separate strip of land between the pavement and the houses – the house boundaries go right up to back of pavement line. Clerk to issue information to residents of Church Rise.
- 6 **Parking**. The Clerk had emailed: "*The GCC TRO team are looking into yellow lines in Church Road. The GCC Parking Team tell me they would be enforced.*" no discussion in meeting apart from noting that we would need to consult with those in the area before it gets implemented.
- 7 **Tree Preservation Orders**. Not discussed in absence of Clerk (Post Meeting Note: Councillor Jones has taken photographs of every tree – still to do an accompanying plan)
- 8 Planning.

a. For Consideration

23/01023/CLP | Erection of a single storey side extension, installation of a front Velux window and rear juliet balcony | Merrowcroft The Rudge Maisemore Gloucester Gloucestershire GL2 8HY – Councillors briefly discussed. No reason to object.

23/00950/FUL | Proposed new dwelling to replace the dwelling on the site of the plot known as 'The Beeches' | The Beeches Persh Lane Maisemore Gloucester Gloucestershire GL2 8HH – During public question time, the owner was handed a copy of a long list of discrepancies in the application documents. The owner acknowledged that he himself had only just discovered that the wrong set of drawings had been submitted with the application. The councillors noted they would not comment presently pending submission of replacement drawings to examine.

b. To Ratify the Comments for Applications and Appeals Submitted Since the Last **Meeting** – None.

c. Decided by Tewkesbury Borough Council – 23/00749/FUL Field House, Blacksmiths Lane, Maisemore, GL2 8HW. Erection of 1 infill detached dwelling, detached garage and driveway on land at Field House. **Granted** on 15 November 2023.

d. Appeals – None.

e. Enforcement Matters – the following issues were discussed and are to be submitted to the relevant bodies by the Clerk:

Marquees – Bugboarding, "Lakeside" and "Hidden Lake", and The Old Vicarage – results of investigations re time limit of allowable time periods without getting consents to be communicated to operators for their comment.

Fencing – 1 Church Road – both exceeding the scope of Permitted Development rules and very ugly in appearance.

The question of potentially "missing" S106 moneys resulting from the Honey Bee Close development due to the village hall was raised. Clerk to investigate.

9 Finance

A. Statement of Accounts - No discussion in absence of Clerk. However councillors sanction relevant payments by the clerk to cover: wages etc, printing, and website costs. Details to be included in January's minutes.
