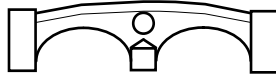


MAISEMORE PARISH COUNCIL



Minutes of Maisemore Parish Council meeting held on Monday 4th November 2019 at 7.30pm in the Committee Room of Maisemore Village Hall.

Items raised in the public session.

- Condition of the A417 through Maisemore.
- Raised manhole cover, near the White Hart on the A417, requires urgent attention.
- Flooding information given out on National radio.

*"Not much to add to comments from the last meeting.
As the PC will have seen water has been restored to all properties in Tewkesbury Borough. Water distribution points were up and running manned by STW.
The repair on the Ham cannot start until the water has receded and therefore the current work around will be in place for at least 2-3 weeks. STW are confident that this will hold and there should be no further problems until the repair is executed.
They will update when the repair is complete.
Flooding
Water will remain high until early this week but there is no specific risk identified.
There are expected to be some road closures in the Tirley / Maismore areas - Phil may have more detail. Waste services have suffered some disruption due to roads being impassable and they will do their best to catch up once areas are accessible again.
Re health
The One Glos health trusts have agreed that the possible downgrade of the A&E at Cheltenham has been withdrawn. Concerns remain about their plans for other county wide services in. Ophthalmology and general surgery. E will know more when the publish details for consultation in the New Year."*

The council would like the 30mph moved back further out of the village at both ends of the A471.
